

# TENNIS TOURNAMENT PEUGEOT 18-19 MAY 2024

## REGULATIONS





#### Art. 1

PEUGEOT TENNIS TOURNAMENT for mixed doubles is intended for amateur players and players who are 18 or older in the year of the tournament, who after the age of 14 have not participated in tennis tournaments and competitions organized by BFTennis and not have been registered with BFTennis in less than 14 years. They were not and currently are not tennis coaches licensed to BFTennis, tennis teachers at universities or other educational institutions (schools, schools and the like), were not and are not currently students at the NSA, specialty "Tennis". These restrictions do not apply to players aged 60 and over on the first day of the tournament and women aged 55 and over on the first day of the tournament.

#### Art. 2

Players from the winning team in the tournament in 2020 and the previous years of the competition can participate in the PEUGEOT TENNIS TOURNAMENT, but not with the same partner. Players from the team winning the tournament from the editions held between 2021 and 2023 (inclusive) are not eligible to participate in the PEUGEOT TENNIS TOURNAMENT.

## Art. 3

Players wishing to participate in the PEUGEOT TENNIS TOURNAMENT need to register online at peugeot.bg/tennis and pay a bank participation fee. Registrations for the tournament are made in pairs (man and woman) or individually (the organizer undertakes to form teams). Registrations are accepted until 17:00 on May 14, 2024.

#### Art. 4

The Chief Judge of the tournament will ensure compliance with the requirements of Articles 1 and 2. The representative of the organizer SFA AUTOMOTIVE reserves the right to disqualify a couple who provided false information. The winners of the PEUGEOT TENNIS TOURNAMENT will be checked again after the final. If they do not meet the requirements of Articles 1 and 2, they will be disqualified and the prize will be awarded to the finalists.

## Art. 5

TENNIS TOURNAMENT PEUGEOT will take place in Tennis Club "Levski - Sofia", a member of the Bulgarian Tennis Federation

#### Art. 6

PEUGEOT TENNIS TOURNAMENT will take place on May 18 and 19, 2024.

SFA AUTOMOTIVE reserves the right to change the dates of the tournament, in case the tournament on the announced dates will be difficult or impossible due to anti-epidemic measures restricting the event and / or due to complicated epidemiological situation in the country. In this case, the participation fees paid will be used for the next announced dates for the tournament.

#### Art. 7

The winners of the tournament, who ranked in the first three places will receive a prize. The winners of the tournament will receive vouchers for travel services from MSJ Travel of different values, distributed among the first three places as follows: for first place - BGN 1,000, for second place - BGN 500, for third place - BGN 300. Travel services may only be used through MSJ Travel and travel services offered by them. Vouchers cannot be exchanged for cash value.

#### Art. 8

PEUGEOT TENNIS TOURNAMENT will be held in 1 set of 6 games without an advantage, with a tie-rack of up to 7 points for equal matches in 6 groups. The final will be played 2 of 3 short sets up to 4 games without an advantage, with 4 draws playing a tiebreak up to 7 points.

Art. 9

Each tournament consists of a minimum of 48 mixed pairs. In order to create a friendly competition, the following formula was established: 12 groups of 4 mixed pairs; 1 pair from each group is ranked. there are 12 teams left, which form 4 groups of 3 mixed pairs: the winner of each group qualifies for the semifinals (draw).

## Art. 10

In the matches in the groups will be awarded:

- 2 points of the winning pair;

- 1 point of the pair lost or left during the match;

- 0 points per pair who gave up before the match or were disqualified. In the event of the final departure of a pair during group matches, all match results of that pair will be void.

## Art. 11

After the end of the matches in one group in case of a tie between 2 pairs, the result of their direct meeting is taken into account.

#### Art. 12

After the meetings in one group with a draw between 3 or more teams, they will be ranked as follows:

- percentage of games won on the total played;

- in case of a new tie of 3 or more pairs percentage of points earned;
- finally, in the event of a new tie of 3 or more pairs by drawing lots.

After determining the pair with the best odds of the three teams, and a new tie in the remaining two teams, the result of their direct meeting will apply. In case of an equal result of two of the teams participating in the meetings, the result of their direct match is taken into account.



Art.13

SFA AUTOMOTIVE will resolve any dispute without appeal and will have the opportunity to change the formula of the competition according to the circumstances.

## Art. 14

Employees of SFA AUTOMOTIVE, as well as those of the importer and the representatives of the Peugeot network, their wives and children are allowed to participate in the PEUGEOT TENNIS TOURNAMENT, but not to receive prizes.

## Art. 15

The participants in the tournament authorize SFA AUTOMOTIVE to distribute their names for free in the media and on the Internet without restrictions, without the right to remuneration, without copyright or other benefits.

## Art. 16

(1) The participants in the tournament authorize SFA AUTOMOTIVE, the organizers, sponsors and the media to use photos and video materials with their participation for advertising purposes.

(2) By registering to participate in the tournament, the participants declare their consent to recieve information related to the tennis tournament to the e-mail indicated by them in the registration form.

## Art. 17

By registering to participate in the tennis tournament, the participants declare that:

(1) They provide their personal data voluntarily; They consent to the personal data provided by them being stored, processed and provided by the personal data administrator, in accordance with the regulations in force in Republic of Bulgaria.
